

Charging the Battery

Charging the Battery

Procedure:

- 1 Connect the USB charging cable to the RSM.
- 2 Plug the charging cable to USB power source.



IMPORTANT: Charge the RSM immediately to prevent flat-battery condition.

Blinking red	Battery is low.
Solid red	Battery is charging.
Solid green	Battery is fully charged.
Blinking green	More than 90% charged.
Rapid blinking red	Charging error.

Battery Indication

Procedure:

- When RSM is not charging, read the following table to understand the indication.

Table 5: Battery Indication

Power Indication	Description
Rapid Blinking Red	Battery level is critically low.
Blinking Red	Battery level is low.
Off  NOTICE: Press the Power button to get the status.	Battery is medium or high.

- Read the following table to understand the audio and bluetooth status indication.

Pairing the RSM to the Radio

Pairing the RSM through Bluetooth

Procedure:

- 1 While RSM is power off, press and hold the Power button until the "Power On" voice prompt follows by "Searching for Host" voice prompt is played and blue LED blinks.
- 2 From the compatible device, search and select "WM500" from the Bluetooth list.
- 3 Once the devices are paired successfully, a "Pairing Successful" tone is played.
- 4 A voice prompt from the RSM indicates that the device is "Connected".
- 5 Choose RSM from the Bluetooth list and pair again for second time (This is for iPhones only).

Pairing the RSM through NFC

Procedure:

- 1 While RSM is power off, press and hold the Power button until the "Power On" voice prompt follows by "Searching for Host" voice prompt is played and blue LED blinks.
- 2 Align the NFC locations on both the RSM and the compatible devices.
- 3 Check the compatible device for indication of successful pairing.

Unpairing the RSM

Procedure:

- 1 While RSM is power off, press and hold the Power button and PTT buttons.
- 2 The blue LED blinks and a voice prompt from the RSM indicates that the paired device is "Cleared".

Replacing the Battery

Prerequisites:



WARNING:

- Before you start the dismantling procedure, power off the RSM.
- Wear an appropriate electrostatic discharge (ESD) protection device.

Procedure:


- 1 Open the USB dust cover.
- 2 Unscrew the three screws from the back housing.



WARNING: Safety Critical

Use a T8 tamper proof torx screwdriver with 3.8 +/-0.1 lbf-in torque to remove the screws.

Figure 2: Unscrewing the Back Housing




- 3 Remove the battery gently from the left.

Figure 3: Removing the Battery




- 4 Insert the battery into the battery compartment. Attach the left side of the battery first.



Figure 4: Inserting the Battery




- 5 Attached the USB Dust Cover using two guide pin on back housing if it detached.

Figure 5: Assembling USB Dust Cover





Figure 6: Securing the Battery





Figure 7: Reassembling the Back Housing



